The celebration is being coordinated by Chanti Koumba, the Peace Corps Regional Recruiter for the Houston area, Ryan Gorczycki, the 50th Anniversary Committee Chair for the GCC-RPCV group, and some members of the GCC-RPCV board. Chanti, as the area recruiter for Peace Corps, will be inviting the Houston community to come join us to celebrate 50 years of Peace Corps, and we are hoping for a large community turnout in addition to area RPCVs.

Peace Corps Partnership Projects Fundraiser Dinner

Board Job Descriptions

President

The President is principal officer of GCCRPCV and serves as chairman of the Board of Directors. He/she presides at meetings of the Board, and serves as an ex-officio member of all committees. The President, with the approval of the Board of Directors, shall create and appoint chairpersons of committees. The President is responsible for the execution of the policies and programs of the Board, and for the administration of the affairs of GCGRPCV.

Vice President

The Vice President shall perform such duties as may be assigned from time to time by the Board of Directors, or the President. In the event that illness or other disability prohibits the President from performance, the Vice President shall have the power to perform the duties that are ordinarily the responsibility of the President.

Secretary

The Secretary is responsible for ensuring that accurate minutes of meetings are taken, approved, and distributed. He/she is sufficiently familiar with legal documents such as by-laws and makes sure they are available at all meetings; acts as parliamentarian making sure Robert's Rules of Order are followed during meetings, fulfills any other requirements of an Officer, and performs other duties as the need arises and/or as defined in the bylaws.

Treasurer

The GCCRPCV Treasurer is primarily responsible for tracking revenue and expenditures for the group. He/she tracks calendar purchases to determine the total amount that can be donated to projects in the Peace Corps Partnership Program and manages the bank and Paypal accounts for the GCCRPCV. The Treasurer prepares an annual report to the NPCA on total expenditures and ensures the proper IRS filing is completed to maintain the group's nonprofit status.

Fundraiser Chair

Currently, the Fundraising Chair coordinates the yearly Peace Corps Partnership Fundraiser Dinner which includes asking for participation of members to provide dishes from their country of service and monitoring the numbers of individuals who will attend the dinner. The Chair researches the Peace Corps web site for the Partnership proposals submitted by Texas

volunteers. Members vote on the proposal(s) to fund with the money raised. The person filling this position potentially has flexibility to identify other areas in which money could be raised to fund the Peace Corps Partnership program.

Webmaster

The Webmaster is responsible for updating the website. The person must have some knowledge of website design is helpful. Must have access to web editing software that allows for uploads (ftp). Being able to convert documents to pdf format is also helpful.

Membership/ Data Base

A good working knowledge of Access or Excel data base is helpful. This person keeps the membership list updated and can provide mailing labels for mail outs and email addresses for email news blasts.

Special Events Planning events and helping with publicity are the main duties of this person.

Archivist The Archivist acts as the historian for the organization.

The above 9 positions are voting members of the Board of Directors per our By Laws. (see: http://www.peacecorpshouston.com/bylaws.pdf) The general membership votes on the Board and then the Board fills the above positions from the elected people. At the Annual Meeting in January 2011, 3 positions on the Board will be open. The people leaving the Board currently hold the following positions: Treasurer, Fundraising, and Vice President. We need new people to join the Board in January. Most likely, these are the positions that you would be able to fill. Call or email the current Board if you would like more information.

Our Connection with KIVA Projects

Since 2008 the GCC group has been giving back by lending money through the organization Kiva. By partnering with existing micro finance institutions (field partners) in developing countries, Kiva, is a very simple way for individuals or groups to provide micro financing to people who have few options for financing. The GCC has made 77 loans, most of about \$25 each. The GCC started with \$700 and has re-lent most of this amount several times over as loans have been repaid. In fact, the GCC has loaned a total of \$2,425 since 2008 without adding any additional funds. The delinquency rate is very low, 3.35% for the loans.

Most of the GCC loans have been made to women (68.5%) in the retail (32.9%) and food (28.8%) sectors. The GCC loans have been fairly evenly distributed among various countries with the two highest recipient countries being Cambodia (8.2%) and Bolivia (8.2%). Through Kiva, there is a real connection to the people receiving the loans, like Christy Evbuomwan, a 58-year old Nigerian woman with 4 children who used the loan to buy and sell sarongs. The GCC, with many other lenders, provided Ms. Evbuomwan a \$675 loan on July 23, 2009 which was completely repaid by April 20, 2010. When repayment is complete Kiva credits our account. We can relend our funds to other entrepreneurs, donate their funds to Kiva (to cover operational expenses), or withdraw our funds. We usually donate some funds to Kiva, but a majority of the money is re-lent. Kiva is a great organization, you should go to their webpage, www.kiva.org, and check it out yourself.

The GCC could not have made these loans without the support of its members (several of whom have made donations specifically for Kiva). Also, many thanks to Lisa Reynolds, the GCC Archivist who has managed the Kiva loans for the past few years!
